## COMPETITION RULES

#### **GENERAL RULES**

- One entry per category per brand
- Products will be tested by The Werc Shop; all entries that fail the pesticide test will be automatically disqualified.
- · Entries must be medicated
- Winners receive a trophy and notoriety as the first ever MEGA COMPETITION winner listed on the official MegaSesh website.
- Entries failing to be packaged according to the specifications listed below will not be accepted.
- There shall be no refunds for rejected or disqualified entries.
- Disqualified entries will be immediately discarded and contaminated enteries will not be returned. Failed test results will be provided to disqualifed entries. Please fully ensure your medicine is safe for consumtion

### **FLOWERS**

- Quarter pound of flowers required for entry. Each entry must be packed in individual zip lock bags with no markings in 1 gram increments. Individual grams must be placed inside larger bags or containers holding the entries with the company name and strain clearly labeled on the larger bag(s). There shall be a total of at least 112 samples.
- Entries are to be judged based on smell, taste, visual appeal, and overall medicinal effects on a scale of 1-10 with 1 being lowest and 10 being highest. Highest overall score wins.

### **CONCENTRATES**

- Concentrates include all consistencies of hash including, but not limited to, oils, waxes, budders, shatters, and crumble extracted using a solvent.
- Minimum one oz of concentrates required per entry. Entries are to be packaged in 0.25 gram increments.
   Concentrates are to be place in parchment paper, white PTFE sheets, or clear jars with no marking on the individual samples. The samples are to be placed in a larger bag or container with the company name, strain, and intended consistency (shatter, sugar, budder, etc.) clearly labeled. There shall be a total of at least 112 samples.
- No non-cannabis derived materials, such as food derived terpenes, shall be infused into the concentrate. All entries with non-cannabis derived materials will be disqualified from qualification.
- Entries are to be judged based on smell, taste, visual appeal, and overall medicinal effects on a scale of 1-10 with 1 being lowest and 10 being highest. Highest overall score wins

### **NON-SOLVENT HASH**

- Non-solvent hash includes all non-solvent concentrates including, but not limited to, dry sieves, water extractions, and co2 extractions.
- Rules and packaging details for non-solvent hash are otherwise identical to the rules governing the concentrates competition.



# COMPETITION RULES CONTD...

### **EDIBLES**

- Edibles include any medically infused product that is to be ingested orally including, but not limited to, food, baked goods, tinctures, capsules, and pills.
- Each entry must have 112 individual packages in generic containers clearly labeled with ONLY dosing (mg of THC in sample) and serving sizes on the individual packages. The individual packages shall be placed in a larger bag or container with the company name, edible, dosing, and serving size clearly labeled.
- If your edible requires refrigeration, we ask that you bring it in a disposable cooler. Megasesh will do our best to ensure proper refrigeration between collection of the entries and the event date but make no guarantee of freshness or non-spoilage.
- Entries are to be judged based on visual appeal, taste, overall medicinal effects, and accuracy of dosing information. Visual appeal, taste, and medicinal effects shall be scored on a scale of 1-10 with 1 being lowest and 10 being highest. Accuracy of dosing information shall be scored based on the ratio of the stated dosing information and the final lab results. A 1:1 ratio shall receive 10 points; the difference between labeled dosing and lab result shall be deducted from the maximum 10 points based on the percentage difference between label and lab results. Highest overall score wins.

### **VAPES**

- Vapes include pre-filled vape pen cartridges or any vaping product intended to be used with a vaporizer mod, such as medicate e-juices.
- Each entry must have 112 individual samples and, if a battery is required, the battery attachment.
- Entries are to be judged based on visual appeal, taste, and overall medicinal effects on a scale of 1-10 with 1 being the lowest and 10 being the highest. Highest overall score wins.
- Due to the nature of cartridges and the often identifiable nature of the cartridges, vapes will not be judged blind.

### **PRODUCTS**

- The products category shall include any infused product that does not fit into one of the 5 listed categories above such as topicals, bath products, lotions, or lubricants.
- Each entry must have 112 individual samples with labels clearly indicating what the product is.
- Entries are to be judged based on visual appeal of the product, packaging, and overall medicinal effects on a scale of 1-10 with 1 being the lowest and 10 being the highest. Highest overall score wins.
- Due to the identifiable nature of products, the category will not be judged blind.

# EXHIBITOR RULES

- No p/a systems, music amplifiers, microphones or megaphones!! (strictly enforced) we are providing live entertainment.
- No exhibiting items without an exhibitor pass, only allowed to bring in large quantity of items with exhibitor pass. Anyone caught in violation risks ejection from the event without refund.
- No selling items with the mega sesh logo on them, we will be selling official mega sesh merchandise. Anyone caught in violation risks ejection from the event without refund.
- No exhibiting of non-medicated food or drink at booth. Only official food vendors will be permitted to sell non-medicated food  $\delta$  drink.
- Exhibitors are financially responsible for any damages caused to booths, drapes, or any property. Do not tape, nail, screw, pin, tack etc., any material to the fabric drapes.
- Exhibitors must be at their booth ready to operate by event opening (12:00pm). After 12pm you may potentially be moved.
- No golf carts. Only official mega sesh staff carts and sponsor cart will be permitted.
- Outdoor exhibitors are to clear their valuables nightly. No sleeping at booth overnight. Private overnight security is available. Ask us for details. Mega sesh is not responsible for lost/stolen property.
- No vehicles will be permitted on the lot saturday morning. All vehicle load-in must be completed on friday. More
  details will be sent to exhibitors.
